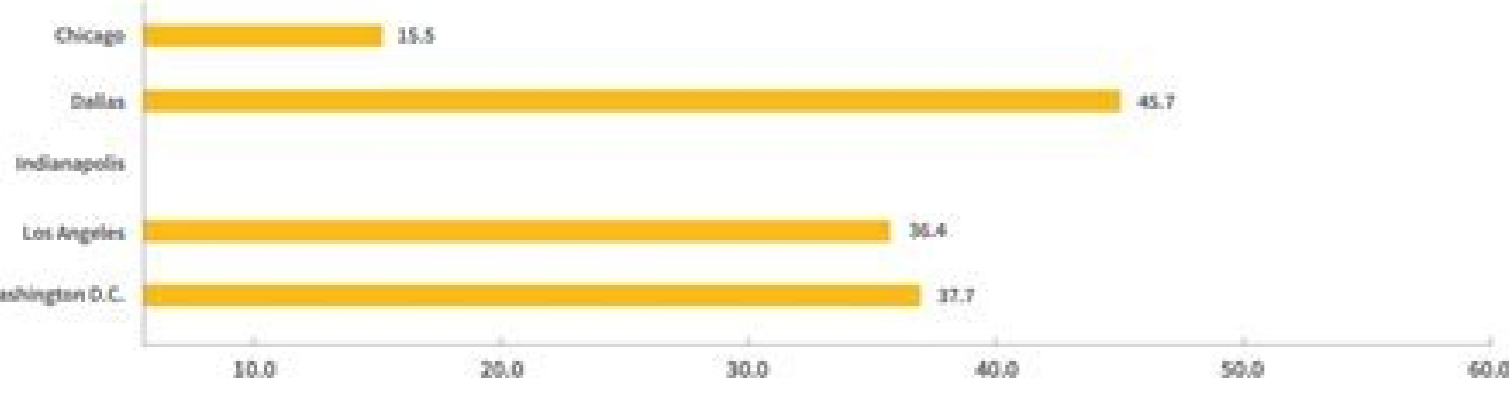
4G LTE & 5G median download speeds (Mbps)
Scale: 0-250 Mbps



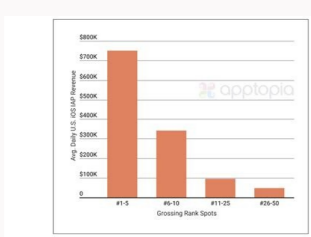
4G LTE & 5G maximum download speeds (Mbps)

With the signing of the China Australia Free Trade Agreement (ChAFTA), opportunities for Australian service providers were set to grow in coming years. We are authorised to issue CoOs under ChAFTA. The CoO certifies that your goods are FTA-compliant, allows them to qualify for preferential tariff rates and may be needed for your goods to clear Chinese customs. It seeks to ensure that customs procedures and practices applying to goods traded between Hong Kong and Australia are predictable, consistent, transparent and trade facilitating. Signatures must be hand-written. Similarly, BV, ICT (including their dependants) and installers or servicers of Australia will be granted temporary entry into Hong Kong, subject to specified conditions or exceptions where applicable. Imports from Australia are not required to be accompanied by a declaration of origin or certificate of origin in order for the goods to enjoy tariff-free treatment. Australia and China have a remarkable trade and investment partnership based on shared interests, vision, and entrepreneurship. To claim zero import tariffs for exports to Australia, Hong Kong producers, Hong Kong exporters, Australian importers or their representatives may complete a declaration of origin in accordance with Article 3.16 of Chapter 3 (Rules of Origin and Origin Procedures) and Annex 3-A (Data Requirements) to the Chapter. The trade negotiations secured numerous future gains for Australian business with Australia's largest trading partner - China. Among the various service sectors in which Hong Kong and Australia have made specific commitments, their services and service providers will enjoy the following benefits in each other's market: access to the market of the other party including the right to establish business to provide services; being treated no less favourably than local service providers under like circumstances; automatically enjoy any additional liberalisation measures which the other party offers to other economies under its future FTAs; and business visitors (BV), intra-corporate transferees (ICT) and independent executives (IE) of Hong Kong will be granted temporary entry into Australia.
